

## Announcement of Mahidol University

On

Additional Guidelines to Up-level the Measures Preventing the Wave of the Outbreak of the Coronavirus 2019 (COVID-19) (April 2021)

Reference is made to the Announcement of the Center for COVID-19 Situation Administration (CCSA) on the 16<sup>th</sup> April 2021 designating high-risk areas as red zones including Bangkok and Nakhon Pathom Province. Additional measures to curtail the upward surge are also suggested to prevent the outbreak of the Coronavirus 2019 (COVID-19). Mahidol University would like all faculties/colleges/institutes in every campus to refer to Mahidol University's Announcement on Work from Home Guidelines and Other Measures to Prevent the Outbreak of the Coronavirus 2019 (COVID-19) dated the 11<sup>th</sup> April 2021, from which further measures are to be added as follows:

1) Item 1 in Mahidol University's Announcement on Work from Home Guidelines and Other Measures to Prevent the Outbreak of the Coronavirus 2019 (COVID-19) dated the 11<sup>th</sup> April 2021 is to be revoked. All buildings and premises of Mahidol University in Salaya, Phyathai and Bangkok Noi Campuses are not permitted to be used for teaching and learning, examinations, trainings or any activities involving a large crowd. The building and premises in those campuses are allowed for the use of healthcare management based on the Infectious Disease Law or the provision of healthcare and quarantine services. Provincial campuses are still allowed to conduct on-site or online academic activities as mentioned in the Announcement dated the 11<sup>th</sup> April 2021.

2) All faculties/colleges/institutes in every campus are to follow the work from home

guideline mentioned in Item 2 in the Announcement dated the 11<sup>th</sup> April 2021.

3) All faculties/colleges/institutes in Salaya, Phyathai and Bangkok Noi Campuses

are to cancel activities with more than 50 people/attendees. Activities with the

possibility of increasing the risk of the Coronavirus 2019 (COVID-19) transmission such

as sports or activities in gymnasiums, closed spaces or in the areas which are difficult

to manage social distancing are not allowed. Only activities authorized by the Bangkok

Metropolitan Administration (BMA) or Nakhon Pathom Province or those relating to

healthcare management based on the Infectious Disease Law or the provision of

healthcare and quarantine services are permitted.

4) Students and staff members in all campuses are advised to strictly observe the D-M-

H-T-T guideline to prevent further transmission of the Coronavirus 2019 (COVID-19).

Please be advised accordingly and this Announcement enters into effect from this

date onwards until further notice.
